

COOKIES

Article 1. DEFINITION.

Cookies are defined as small text files saved on the User's computer and used to facilitate navigation on the website by identifying the services and sections used by the User, to ensure the proper functioning of the services offered on the site, to allow the use of the main functionalities of the site, and, where applicable, to ensure the operation of advertising services.

The data collected by cookies is anonymous as it does not allow to identify the User.

Cookies are managed by the User's internet browser.

Only the issuer of a cookie is able to read or to modify the information contained in a cookie.

Article 2. COOKIE TYPES.

2.1. Internal Cookies.

Internal cookies are the cookies inherent to the www.epayspace.com website.

2.1.1. Statistics Cookies.

This type of cookies allows to establish the statistics of visits to the www.epayspace.com website and, if necessary, to detect problems of a technical nature in order to improve the website's functioning.

2.1.2. Functional Cookies.

This type of cookies allows the proper functioning of the website services. These cookies allow among other things to memorise the display preferences of the website.

These cookies also ensure the security of electronic communication services.

2.2. Third-party Cookies: Cookies from Partner Companies.

The E-Pay Space SAS company ensures, as far as possible, that the cookies used by its partners comply with the legal provisions relating to the personal data protection.

2.2.1. Partner Cookies.

Cookies can be deposited and used by the E-Pay Space SAS partners in order to provide certain services necessary to the website functioning.

2.2.2. Advertising Cookies.

If applicable, the advertising cookies may be deposited on the User's computer in order to identify his fields of interest and to collect his browsing history in order to customise the advertising offer.

Article 3. ACCEPT OR REFUSE COOKIES.

In most cases, the User decides whether he allows cookies to be deposited on his computer or not.

However, some types of cookies do not require the User's consent, as these cookies are strictly necessary for the provision of the services requested by the User.

3.1. Cookies Authorisation.

Cookies authorisation is given for a maximum duration of thirteen (13) months, this duration being equal to the cookie's "lifetime".

By accepting cookies, the User accepts that the information retrieved by cookies shall be saved for a maximum period of thirteen (13) months. This information shall only be available to the cookies' issuer.

3.2. Cookies Refusal.

If the User chooses to refuse cookies, a number of the website's functionalities shall become unavailable to him. This is particularly the case for all the functionalities requiring the User's identification (if applicable).

In the event that the User refuses cookies, the E-Pay Space SAS Company informs him that it declines all liability concerning the website's malfunction or the unavailability of certain services.

3.3. Cookies Management.

The User may at any moment deactivate cookies by configuring his web browser:
